## STATUTORY DECLARATION

### UNDER SECTION 4 (1) (b) OF THE RIGHT TO INFORMATION (RTI) ACT, 2005.

#### Right to Information (RTI) Act, 2005

The Honourable President of India gave his consent to the Right to Information Act, 2005 on 15.06.2005 and the same has come into existence with effect from 12.10.2005.

The Right to Information Act, 2005 sets out the practical regime of Right to Information for citizens to enable them to access the information under the control of public authority in order to promote transparency and accountability in the working of such authority.

As per the Act, “**Information**” means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.

As per the provisions of the Right to Information Act, 2005 a citizen can seek for the information in relation to a public authority which is established, constituted, owned, controlled or substantially financed by funds provided directly or indirectly by the State Government by an application to the Public Information Officer. The Right to Information is a right conferred on the citizens of India only.

Section 2(h) of the Act defines “**Public authority**” as any authority or body or institution of self-governance established or constituted by or under the constitution or by law made by the Parliament or any state legislature or by notification issued by the appropriate Government. It includes body owned, controlled or substantially financed by the government.

In accordance with the provisions contained in Section 2(j) of the Act, Right to Information means right to information accessible under this Act which is held by or under control of a public authority.

**Smt. Allum Sumangalamma Memorial College for Women, Ballari**, established in the year 1969, is an Aided Institution, Grant-in-aid HEI imparting Women's Education and affiliated to Karnataka State Akkamahadevi Women's University. The college is owned, governed and managed by its Management Veerasaiva Vidyavardhak Sangha, Ballari. The College has been included under Section 2(f) and 12B of UGC Act, 1956. The College is accredited by NAAC (III Cycle 2017) with B<sup>+</sup> Grade. The College discharges its functions in accordance with the rules and regulations established by Karnataka State Akkamahadevi Women's University, Vijayapura, and amended from time to time and instructions/orders issued by Directorate of Collegiate Education, Government of Karnataka.

The financial transactions of the Institution are audited by internally and externally by the Chartered Accountant duly appointed by the Veerasaiva Vidyavardhaka Sangha Management and Government AG Audit. The College has different bodies to maintain all types of disciplines on the campus. All the cells/committees of the institution are under Statutory Bodies and come under the purview of section 4(1)(b) of RTI Act, 2005.

The applications under the RTI Act, along with a postal order/demand draft for Rs.10.00 (or the fee applicable at the time) obtained in favour of Principal, Smt.A.S.M. College for Women, Ballari, may be sent to the Principal or handed over directly in the office. Copies of documents will be charged separately if applicable as per the Act. All information about the College under Section 4(1) (b) of RTI Act, 2005 hence, are open for the public perusal and any of them can be obtained by a citizen of India.
